Eclectic. Physiotherapy & Rehabilitation respects the privacy concerns of the users of its website, https://eclecticphysio.com and the services provided therein (the "site"). The Company thus provides this privacy statement to explain what information is gathered during a visit to the site and how such information may be used.

Use of Information: As a general policy, no personally identifiable information, such as your name, address, or e-mail address, is automatically collected from your visit to the site. However, certain non-personal information is recorded by the standard operation of Eclectic. internet servers. Information such as the type of browser being used, its operating system, and your IP address is gathered in order to enhance your online experience.

The site's various mailing lists, downloads, special offers, contests, registration forms, subcription and surveys may request that you give us contact information such as your name, mailing and/or e-mail address, demographic information such as your age and gender, and personal preference information such as your preferred software and interests. Eclectic. may disclose user information in special cases when we have reason to believe that disclosing this information is necessary to identify, contact or bring legal action against someone who may be causing injury to or interference (either intentionally or unintentionally) with the Eclectic.'s rights or property, other users of the site, or anyone else that could be harmed by such activities.

How do you collect information?

APPENDIX

1. Risks of using electronic communication

- Use of electronic communications to discuss sensitive information can increase the risk of such information being disclosed to third parties.
- Despite reasonable efforts to protect the privacy and security of electronic communication, it is not possible to completely secure the information.
- Employers and online services may have a legal right to inspect and keep electronic communications that pass through their system.
- Electronic communications can introduce malware into a computer system, and potentially damage or disrupt the computer, networks, and security settings.
- Electronic communications can be forwarded, intercepted, circulated, stored, or even changed without the knowledge or permission of the Physician or the patient.
- Even after the sender and recipient have deleted copies of electronic communications, back-up copies may exist on a computer system.

Others:
